Rear Garden:

T1 Bay: Approximately 3.50m: Fell to as near to ground level as is practicable. Tree is growing very close to boundary wall and is causing cracking. If retained it will continue to damage the wall. Control hazard potential.

T2 & T3: 2 x Mature Acer's: Approximately 4.00m& 2.00m: Reduce crowns by approximately 20% (up to approximately 0.50m-0.75m). Thin crown density's by 20%. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
