to re-pollard 2 x trees T1-T2 Sycamores on attached map, this pruning is inline with historic pruning- tree are starting to interfere with neighbouring property, close to roof tiles and one tenant cant open the window of Andrew Court Wedderburn Road,London,NW3 5QE. we will be removing 2-3m all round, making sure not to prune past previous pruning/pollard point.
