Replacement of window on rear elevation at lower ground floor level with timber frame sash window within enlarged opening.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: P01 rev R01 to P04 rev R01 (inclusive), P05 rev R00; Design and access statement from WAY Architecture Yell Ltd. received 20/09/2024; Cover Letter from WAY Architecture Yell Ltd. dated 18/09/2024.

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017, and policy D3 of the Kentish Town Neighbourhood Plan 2016.

Informative(s):

1 Reasons for granting planning permission:

The proposed replacement window is considered to be acceptable in terms of its design, material, location, colour, proportions and opening method, such that, the character and appearance of the host building and wider Bartholomew Estate Conservation and Kentish Town Neighbourhood Areas would be preserved.

Though the proposed window would be marginally larger than the existing window being replaced and slightly repositioned, it is noted a being mainly concealed from public view by virtue of its rear, lower ground floor location, as well as, its position beneath existing external stairs which lead from ground floor level to garden level below.

While there would be some degree of increased thickness to the window frame in order to accommodate double-glazed panes, in this instance, the proposed use of a suitably designed unit is considered to be an appropriate and sympathetic change.

In sustainability terms, double-glazed units are also noted as having the potential to reduce energy costs, provide more thermal efficiency and insultation, offset the need for powered heating and so help reduce carbon emissions, and allow for passive flow of ventilation in some cases.

There are no amenity concerns as the proposal involves the replacement of existing fenestration in a similar lower ground floor level position at the rear of the property.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Bartholomew Estate Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Area) Act 1990

as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies A1, D1, D2 and CC1 of the Camden Local Plan 2017, policy D3 of the Kentish Town Neighbourhood Plan 2016, the London Plan 2021 and the National Planning Policy Framework 2023.
