T1-Magnolia(M.soulangea)
-reduce crown by 25%(1.5m from tips) to suitable growth points
-thin by 15% to allow more light through canopy
-lift on pavement side by 0.5m to give greater clearance

Rear garden

T2-Hawthorn(Cratageous monogyna)

- -remove all ivy growth to top of wall level
- -reduce crown by 25% to suitable growth points
- -trim back branches overhanging pavement and inner side closest to house

All works are for routine maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
