Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- Approximately 9m height ash tree cr2.5m on the side of no.33 back to previous pruning points.
- Formatively prune the side of no.31 to balance with a light thin of 15/20%
- Remove two codependent suckered growths at the base of the ash tree.
- The removal of the two stems will allow more light to seep through and will not take away from the overall perspective of the Ash tree.

Olive tree

- ct 20% and formative prune, allowing air and light to enter the canopy and reduce the canopy density.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
