## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- G1: 4 x Birches Crown reduce height and spread by 20% to make more compact (approx. 1.5m height and 1m spread)
- G2: Ash + Elderberry Reduce all overhang back in line with boundary and metal railing (approx. 2m)
- T2: Large Lime Crown reduce spread towards building to give a clearance of 2.0m

  Crown thin by 15% and remove major dead wood
- T4: Large Hornbeam Remove major dead wood in lower canopy
- T5: Handkerchief Tree Large limb growing towards to east, showing signs of stress

  Reduce limb back to previous reduction points to alleviate end weight (approx. 2.5m)
- T6: Walnut Remove major dead wood from crown
- T8: Birch Remove broken branch
- T9: Oak Remove major dead wood
- G5: 2 x Pear In an avenue of Pear trees, reduce to match smaller trees

  Crown reduce height by 1.2m to convenient growth points

  Crown reduce spread by 0.5m to convenient growth points
- T10: Lime Crown thin by 15% to let more light penetrate the crown, remove dead wood
- T11: Very Large Ash Previously been reduced heavily.

  Reduce one over extended branch growth towards the North East by 4 5m to alleviate end weight to prevent the branch from failing
- G6: 3 x Holly Reduce crowns to a uniform shape/hedge form
- T12: Ginkgo Crown reduce the height by 2.5 3.0m

  Reduce extremities growing towards building to give a clearance of 1.5m

Maintenance works in line with good arboricultural practice

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

## Sketch plan requirements

**Tree Ownership** 

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
