T1: Pittosporum (6m): Fell as it is a poor specimen, co-dominant stem at base which will require pruning to avoid risk of failure creating a dense and unsightly crown. Fell and replant with a more appropriate species.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
