(TPO REF: C10-T73) FRONT GARDEN: 1 x Lime (T1) - Reduce crown to points of previous reduction, (3m - 4m height reduction, 1m - 2m from lateral growth. Crown lift to 7m - 8m from ground level (epicormic growth).

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)


Reason: To ensure the preservation of the amenity value and health of the tree(s).
