Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1 Meidum Willow in south west corner of the garden. There is possible root plate disturbance which can be seen in photo 'T1 Willow east side. Re-pollard back to old pruning points to alliviate weight on the root system. Leave rear branch on the south side of stem to help balance of the tree and promote growth on that side of the tree.
- T2 Medium to large Oak in rockery in the centre of the garden. Reduce all over by 2m or less, to previous reduction points or closest suitable growth point leaving secondary growth to reshape the tree. Thin and clean internal crown.
- T3 Medium Hawthorn at the end of the side access alleyway to the garden, located on the north side of the property. Target prune back to shape by reducing over extended laterals. Remove any deadwood.

All works to be in accordance with the recommendations in British Standard BS3998:2010 (Recommendations for Tree work).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
