T1 - purple plum tree (5m) - remove split limb across path that's touching wall of church lift remaining branches over path to approximately 2.5m from ground level and reduce branches growing E by approximately 2m.
T2 - holly tree (6m) - reduce height by approximately 3m to below gutter height of church.
T3 - pyracantha bush (5m) - reduce height to approximately 2.5m from ground level and reduce lateral branches away from path.
TA elder tree (5m), take down to ground level
