Rear Garden:

T1: Mimosa: Approximately 6.00m: Reduce crown back to previous and most recent reduction points, approximately 1.00m. Reduce lateral and sub lateral growth growing over lawn by approximately 1.25m-1.50m.

T2: Variegated Holly: Approximately 6.00m. Reduce crown by approximately 0.75m.

T3: Portuguese Laurel: Approximately 6.00m. Reduce hard back from the lawn up to approximately 0.50m. Thin crown density throughout by approximately 20-25%. Reduce crown height by approximately 1.25m. Raise crown by approximately 1.20-1.50m to reveal main stem.

T4: Mature Pyracantha: Approximately 5.00m. Fell to ground level and treat with systemic herbicide.

Reason: Overcrowding with Portuguese Laurel.

T5: Large Bay: Approximately 7.00m. Reduce crown by approximately 30% (1.50m). Prune hard back from lawn side up to 1.00m, raising low crown by up to approximately 1.50m to help clear site line.

T6: Small Bay- (nearest shed): Approximately 5.00m. Fell to ground level and grind stump to approximately 250mm below current ground level.

Reason: Overcrowding with Large Bay.

T7: Acer: Approximately 3.50m. Thin crown density by approximately 20% concentrating mainly on the lower crown area.

T8 & T9: 2 x Pencil Pines: Approximately 8.00m. Trim wayward branches back into main crown structure up to 1.00m to tidy.

Reason: General maintenance unless otherwise stated.

Front Garden:

T10: Mature Holly: Approximately 5.00m. Tip prune by up to 0.75m.

Reason: To help control encroachment.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
