This tree has been historically pollarded. This tree work is a cyclic re-pollard to maintain size for maintenance purposes
T1 – Horse Chestnut - Re reduce back to most previous reduction points by approx 1.5m maintaining lower screening over car park. Reduce one side lateral branch by approx 1.5m and prune in a forward section of an upper limb to the nearest side branch by approx 1m.
