In accordance with the above regulations, where a proposed development consists of the installation, alteration or replacement of a mast within 3 kilometres of the perimeter of an aerodrome, the developer shall notify the Civil Aviation Authority, and the aerodrome operator*, as appropriate, before making an application to the local planning authority for a determination as to whether the prior approval of the authority will be required as to the siting and appearance of the development.

I give notice that Perry Williams Ltd, 112 Dunkirk Avenue, Desborough, Northamptonshire, NN14 6PN on behalf of Cornerstone will be applying to Chief Planning Officer, Planning - Development Control, Camden Council, Camden Town Hall, London, WC1H 8ND, under the above regulations for its determination as to whether the prior approval of the authority will be required as to the siting and appearance of :

Full description of proposed development: **The proposed installation of 3 no antenna on 4.8m / 3.8m support poles together with 1 no equipment cabinet and ancillary development thereto on the rooftop of 58 Kingsway. Top height of masts 31.00m / 30.00m AGL.**

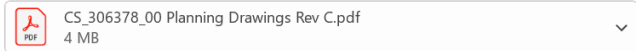
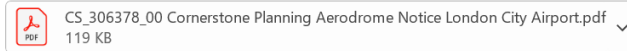
