Hi we need permission to reduce the crown by 30% as the tree is now blocking light and is overgrown. Photos are attached to this application. Previously Camden Council has given permission every couple of years without a detailed plan as photos have sufficed. These are attached.

Identification of Tree(s) and Description of Works

Cherry tree requiring a crown reduction of 30%. Tree is situated within boundary of the property on Lyndhurst Garden side. Camden has previously granted permission for same works in 2019. When in full bloom this summer there was a significant reduction in light as the height is now up to the second floor windows blocking light.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
