Sycamore T1 (16M high, 500mm dia.) - Reduce the crown overall by up to 2 metres.
Pine T2 (22M high, 700mm dia.) - Reduce the crown lateral branching on property side back to a suitable growth point, to create a 2 metre clearance from the building.
