Front Garden:

T1: Mature Sycamore: Approximately 8.00m-9.00m. Remove major dead wood throughout. Thin crown density by 15%. Remove epicormic growth. Tip prune to reduce overlong branches back into main crown structure by approximately 0.50m. Remove ivy from crown structure and main stem down to hedge height. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
