Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Common beech (T006) - Within Conservation Area. Not covered by TPO. Prune back from the building on northern aspect by 2 metres from branch tips, back to previous pruning points and suitable branch junctions, leaving a finished spread on northern aspect of 4.5 metres. Tree crown is slightly further away from the building than T007 and T008, but the residents would benefit from pruning back works, due to windows that are within a few metres of the northern aspect of the tree crown.

Holm oak (T007) - Within Conservation Area. Not covered by TPO. Prune back from the building on north-eastern aspect by 1 metre from branch tips, back to previous pruning points and suitable branch junctions, leaving a finished spread on north-eastern aspect of 1.5 metres. Close proximity to building. Tree crown is heavily reducing light ingress to various windows.

European lime (T008) - Within Conservation Area also covered by TPO. Council owned. Prune back from the building by 1 metre from branch tips, back to previous pruning points and suitable branch junctions, leaving a finished spread on north-eastern aspect of 1 metre. Close proximity to building. Tree crown is reducing light ingress to various windows. Possible caveat for the tree to be maintained by 79 Fitzjohns Avenue.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
