Rear Garden: T1: Mature Ailanthus: Approximately 14.00m: Fell to ground level- grind stump to 300mm below current ground level. This mature tree has been historically managed by means of pollarding. Most recently pollarded in 2022. Tree is growing within very close proximity to the external boundary wall (approximately 300mm) at close proximity (within approximately 300mm) to an external boundary wall of Building A. Berkley Works, Primrose Hill. NW1 8XY.
The wall at Berkley Works has over the year sustained substantial and progressive damage despite the trees regular and intensive
management regime. As attempts to mitigate the trees influence on the adjacent wall have been unsuccessful and damage caused is significant, the tree owner has consented to the removal of the tree.
We are including a recent structural engineers report from RPH Engineering which includes current photographs of the damage to the wall.
Our Associate Martin Dobson from Martin Dobson Associates has viewed the report and recommended that an application be submitted to remove the tree.
ou might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
