T1 - Cherry tree close to back of house- (15m)- crown reduction of approximately 1.5m on all aspects of tree, prune back from roof by 1m and remove dead branches.
T2- Hawthorn tree- crown reduction of approximately 1.5m.
T4 - five ivy clad lime trees (12-14m) - reduce height of ivy to approximately 6m from ground level.

T5 - laurel tree (8m) - reduce crown by approximately 2m.

T6 - laurel tree (5m) - reduce crown by approximately 1.5m.

T7 - holly tree (5m) - reduce crown by approximately 1.5m.

T8 - holly tree (9m) - reduce height by approximately 3m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
