1 x Cherry (T8) - Fell to ground level.  
1 x London Plane (T9) - Crown Reduce by 4m.  
1 x Sycamore (TG1) - Fell to ground level.  
FRONT GARDEN: 1 x Ash (T13) - Crown Reduce by 2m.

The Council has considered your notification of intended works to trees dated 08 November 2024 and does not wish to object.
