T1 - Weeping Willow - Pollard to previous pollard points, at main trunk, approx 6m. from ground level (5m. approx. branch removal)
This is routine maintenance, to keep the tree within a reasonable size for its location in a small garden overhanging the canal, and will prevent branch failure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
