Tree location - whole site

Reason for works - Tree work is to be undertaken to remove dead branches to improve form and increase safety in accordance with good arboriculture practice and maintain the future wellbeing and growth of the trees.

Tree no. 3 Yew H13m stem dia 720mm SM

Reduce crown overall (in height and lateral spread by 2-2.5m)

Tree no. 9 Lime H14m stem dia 750mm SM

Remove regrowth formed since most recent reduction/Remove basil and epicormic shoots

Tree no.14 Ash H9m stem dia estimated 270mm SM

Remove regrowth formed since most recent reduction.

Tree no. 15 Cherry laurel H7m stem dia estimated 250mm SM

Remove regrowth formed since most recent reduction.

Tree no. 16 Deodar Cedar H10-15m SM Crown reduce height and sides by 2-3m

Tree no. 17 Elder H3.5m stem dia 500mm (at 0.5m) M

Remove regrowth formed since most recent reduction.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
