1. Personal Impact on My Property

- The proposed development will directly affect my property due to:

- Overshadowing: The increased height and scale of the extension will reduce natural light into my home and garden.

- Loss of Privacy: Windows or balconies in the proposed extension will overlook my property, impacting my family's privacy.

1- Block Plan
