51 Site Investigations Prior to the commencement of site investigations involving a borehole or trial pit deeper than one metre with the potential to cause impact on HS1 assets, details of the location and depth of site investigations including a method statement shall be submitted in writing and approved by the Local Planning Authority in consultation with HS1. This activity shall then be carried out only in compliance with the approved details unless previously agreed in writing by the Local Planning Authority in consultation with HS1.
Reason: No such information has been provided and is required in order to ensure that the borehole or trial pit is at an acceptable vertical and horizontal distance from tunnels, the operational railway or other assets as advised by

HS1 so that it does not compromise the integrity, safety or operation of HS1, in accordance with the requirements of policies G1, D1, A1, and DM1 of the London Borough of Camden Local Plan 2017.

Summary of discussion at meeting

- Arup presented the scheme in outline including basement construction, together with the site investigation proposal (boreholes, trial pits, in situ testing and monitoring) to inform design and discharge of planning conditions by LC Camden. Details of the scheme are available on LC Camden planning website.
- Proposed site investigation locations are outside 10m from the Thameslink station box in plan.

- The works are due to start on site 6 January 2024 by Concept Ltd as Principal Contractor, for a period of 6-8 weeks.
- For this stage (SI) NR do not expect to require formal appointments (CRE, CEM).
- For this stage SI, Form A,B are not expected to be required. NR(AB) is arranging a Construction review of the proposals to confirm further consideration for the proposed locations, if any, however not expected to be required based on information provided/summary given.
- Outlined in overview, additional utility trial pits to be carried out adjacent to the NR Thameslink box. (this is specified separately see below).
- NR noted preference for documents to be shared by email as primary source, rather than ASPRO portal.

Note to follow meeting- Bob Newbould is to be the engineering lead for NR, to include in this and future correspondence.


