9. Conclusion
The proposed glass tower extension and roof terrace extension would both be acceptable
in principle, however would require amendments as the current proposed design would
not be acceptable. Although the extension to the glass tower is acceptable due to the
matching materials and design, the roof access above is not appropriate and would not be supported. Similarly, a winter garden in the place of the existing roof terrace would not be
objected to, however the current design does not integrate successfully with the host
building and would constitute an overly dominant and prominent addition, particularly due
to the replacement of the brick parapet with fully glazed balustrading.
The equipment to the roof of the building is also partly acceptable; the addition of an
ASHP and installation of photovoltaic panels is acceptable in principle, but air conditioning would not be supported in this context, unless fully justified. The noise impact assessment
would also need to be reassessed at application stage by the Council's Environmental
Health Officer to confirm there is no unacceptable impact on amenity.
