Strawberry tree - Crown reduce the height by 1.5m Crown reduce the spread by 1.0m Crown reduce extremities growing to property to give a clearance of 1.5m Crown thin by 10% and remove dead wood

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
