Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1. apple tree reduce and prune thin crown by 25% reduce ivy on stem to below crown break.

T2 mature Sycamore to reduce new growth back in upper crown area and remove 2 lower branches on trunk under main crown area leave a line of defence so the trunk is further protected. Upper crown growth to previous (last) points not to reopen older limb or expose older sapwood and branch form. Length approx 3.5m

T3. A early mature poplar tree self set which has no future under T2 Sycamore and leaning away from this larger tree to get light may fail in future as crown is all on this lean side towards railway -wall -private garden boundary and property.

T4. Young sycamore sapling group of 2 one approx 70mm in diameter to remove one 100mm diameter approx to remove no future against historic boundary wall.

T5. Sycamore single stem crown upper to reduce new growth back to last -previous points again not to reopen older limb-open sapwood that is mature, branch length approx 3.5m

T6. Sycamore single stem mature crown growth which is recent to remove back to previous points as following suit of other proposed.

T7. Ash tree mid mature tree low vigour growth has not responded well maybe 0.5m growth max from pruning of 4.5 years ago indicates a problem also with a large cavity column in base trunk starting at ground level and reaches approx 4m and has a significant opening in diameter which structurally is comprised. We would like to propose a fell for fear of safety. there are young ash trees number (3) around this tree which will take its place .

T8 twin stem Sycamore tree to prune back new growth to previous points as per group of sycamore , approx branch length 3.5m.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
