Many Institutions have shown considerable interest since Holger's death in 2001. Parts of the Hilde Holger Archive which already are housed in institutions: The National Portrait Gallery have acquired several photos and a drawing of Hilde Holger from this archive. The Österreichisches Theatermuseum in Vienna have photos of Hilde Holger. The New York Public Library for the Performing Arts at the Lincoln Center in New York have articles and videos of her work. The Brooklyn Museum of Art showed the film of Holger's Inclusive Dance Legacy. The Library of Congress in Washington DC have some of her videos and diary. The United States Holocaust Memorial Museum have records of Holger's family. This extension was built before the Centric Close development at the back/ The fact that the developers have paid for the loss of light establishes that there is loss of light. In the meantime. Primavera's house, along with the other three terraced houses, has Article 4 Direction (A4D) added to the Conservation Area ruling. A4D is part of planning legislation that allows the council to remove permitted development rights including changes of use from an area or a particular property in certain limited situations where it is necessary to protect local amenity or the well being of an area.	
				 2.1 Concerning Ground Foundation Damage due to deep Drilling and Ground Water displacement, possibly to Primavera's Property. Already the previous Centric Close development behind 27 Oval Road has caused major cracking that costs tens of thousands to put right. And has not been done for lack of funds. More piling and digging for the foundation of a double storey extension at 29 Oval Road will damage the very expensive reinstatement of the major Thames Water flood in 27's basement that occurred before the reinstatement of 2009/2010. CDM waterproofing was installed after digging down 4 feet by hand and filling the basement with rough stones. Any slight ground movement would severely compromise the plastic on all the walls and floor, and Sheet Rock walls in front of the outside and Party walls. Then the HS2 will soon be digging and tunneling, on the other side of the very nearby train tracks As it is at present, the fast trains now since Centric Close was built, cause considerably more vibration in 27 Oval Road!
