Town and Country Planning Act 1990 (as amended) **NOTIFICATION OF AN APPEAL**

The Council has been notified of an appeal against the enforcement notice EN24/0168, which has been made to the Planning Inspectorate. The appeal concerns property at:

44-46 Caversham Road, London, NW5 2DS

and the breach of planning control alleged in the enforcement notice is:

Without planning permission: The change of use from Use Class B8 (Building materials storage) to use as a car park (Class Sui Generis).

and the reasons for issuing the enforcement notice are:

- -The change of use has occurred within the last 10 years.
- -The use of the land for car parking is contrary to policies G1 (Delivery and location of growth) and H1 (Maximising housing supply) of the Camden Local Plan 2017 on the basis of ineffective and inefficient land use, and housing as the priority land use of the Local Plan.
- -The use of the land for car parking promotes the use of private motor vehicles, fails to encourage the use of sustainable modes of transport, exacerbates local traffic conditions and harms local amenity, contrary to policies T1 (Prioritising walking, cycling and public transport), T2 (Parking and car-free development) and A1 (Managing the impact of development) of the Camden Local Plan 2017.

and the required action is:

Within a period of ONE (1) month of the Notice taking effect, on 25/09/2024: Cease the use of the site as a Car Park (Class Sui Generis) .
