The application seeks permission to temporarily deconstruct 2 bays of the Outer Circle dwarf wall as part of an site access solution. This site access solution is an alternative for the solution previously granted as part of the full wall and balustrade replacement application.

The planning permission granted covered the access for the proposed construction site via the Chester Terrace carriageway. Planning permission is being sought to allow for an alternative means of access. The alternative means of access would be for construction traffic to access the site via the Outer Circle which is seen as less disruptive.

After completion of the works, the 2 dwarf walls would be re-constructed like-for-like to match existing.

The works propose to temporarily deconstruct 2 no. bays of a dwarf wall on the Outer Circle. The dwarf wall is a boundary between the Outer Circle Footpath and the Chester Terrace Gardens. The works are localised between the brick piers. The metal railings will be carefully removed and restored. The dwarf brickwork will be demolished. The brickwork will then be reinstated like-for-like.

Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?

The proposal is to temporarily deconstruct the dwarf wall to allow for construction traffic access from the Outer Circle into the Chester Terrace Gardens. This is seen as a less disruptive means of access onto the construction site for the granted "Chester Terrace Balustrade and Retaining Wall Works". Planning permission and listed building consent were granted for the reconstruction of the inner balustrade in August 2024. This included permission for a ramped access from the terrace carriageway down into the gardens for the proposed construction methodology. Since the original application, an alternative access method involving less disturbance has since been identified. This will minimise the impact on the fabric of the perimeter wall and cause less disturbance to residents during the 1st phase of the works.

The final construction methodology will be to the contractors' proposals – so access from the terrace carriageway may still be preferred by the contractor. However, in the interest of providing an alternative solution, that may be less disruptive to residents, a new planning permission and listed building consent is being applied for.

The alternative proposal, for which planning permission and listed building consent are now sought, involves the dismantling of two bays of the outer boundary wall to create a level access into the gardens from the Outer Circle. The existing brickwork and later post-war railing would be carefully removed and set aside in a secure location. The granite kerbs and York stone paving to the footway of the Outer Circle would be completely protected with reinforced sheeting capable of withstanding the passage of heavy vehicles. On completion of the works, the wall and railing would be reinstated to seamlessly match the appearance of the existing adjacent work. If any damage occurs to the kerbing or paving then these will be replaced with like-for-like granite kerbs or yorkstone pavers.
