### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

REAR GARDEN: 1 x Acer (T3) - Fell to ground and treat remaining stump with herbicide to prevent regrowth.

1 x Gleditsia (T4) - Reduce all aspects of the crown by approx. 1m to create a tight and tidy shape.

1 x Conifer (T5) - Reduce height by approx. 2m - 2.5m. Reduce size by approx. 1m - 1.5m.

1 x Yew (T6) - Reduce height by approx. 2m. Trim sides to create a tidy shape.

1 x Apple (T7) - Reduce all aspects of the crown by approx. 2m - 2.5m. Thin by 10%. Remove crossing branches.

1 x Hawthorn (T8) - Reduce height by 2.5m and shape.

The Council has considered your notification of intended works to trees dated 11 December 2024 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
