NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Acacia (T1) - Thin crown density by 20%. Reduce lateral and sub lateral growing over planting beds and growing along the boundary line by up to approx. 1.2m - 1.5m. Reduce remaining overlong branches back into main crown structure to tidy and shape crown, approx. 1.2m.

1 x Birch (T2) - Reduce lateral and sub lateral branches overhanging the lawn by approx. 1.2m.

1 x Cherry (T3) - Reduce lateral and sub lateral branches which overhang the lawn and protrude from the crown structure back into the main crown structure by approx. 1.2m - 1.5m.

1 x Magnolia (T4) - Remove collapsed Magnolia and Grub or grind out stumps.

The Council has considered your notification of intended works to trees dated 17 December 2024 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
