LAI, Local Preacher, King's Cross Methodist Church</p> <p>I have been attending King's Cross Methodist Church since August 1994 and currently serve as one of its local preachers. I strongly and wholeheartedly support the proposed redevelopment of our church, which I believe will secure its future as a vital spiritual and community hub.</p> <p>King's Cross Methodist Church has been a cornerstone for more than 300 members of our congregation, providing a place to grow in faith, deepen our understanding of God, and serve the wider community. Over the years, the church has exemplified its mission to act as a channel of God's love and care, often stepping up in times of need and crisis.</p> <p>I vividly recall 7 July 2005, a day of tragedy when a series of bombings brought London to a standstill. Nearby underground stations were shut, and public transportation ceased to operate. Our church opened its doors immediately, offering frightened and distressed passers-by a place of safety and respite. While the provisions were simple—a cup of tea, coffee, or the use of a phone to contact family—the warm and peaceful environment provided comfort and solace to those affected. People prayed, rested, and found reassurance in the care extended by our church.</p> <p>During the 2012 London Olympic Games, King's Cross Methodist Church once again served the community by remaining open daily to athletes, volunteers, and tourists. We offered refreshments, rest areas, and facilities to support those visiting or passing through this vibrant area. Partnering with social service entities, the church fulfilled its mission to serve both spiritual and practical needs, reinforcing its role as a caring presence in the heart of the King's Cross neighbourhood.</p> <p>However, while our mission and dedication remain unwavering, the physical state of our church building tells a different story. At over 200 years old, the facilities are increasingly outdated and do not meet modern standards. Maintenance costs are escalating, and the current infrastructure is ill-equipped to meet the growing demands of our congregation and the wider community. Without redevelopment, these challenges will continue to hinder our ability to serve effectively.</p> <p>I firmly believe that the proposed redevelopment is essential for the church to thrive. A modern, purpose-built facility will enable us to continue and expand our mission, foster stronger ties with the community, and offer a space that reflects the church's commitment to inclusivity, care, and spiritual growth.</p> <p>Thank you for considering this vital redevelopment proposal.
