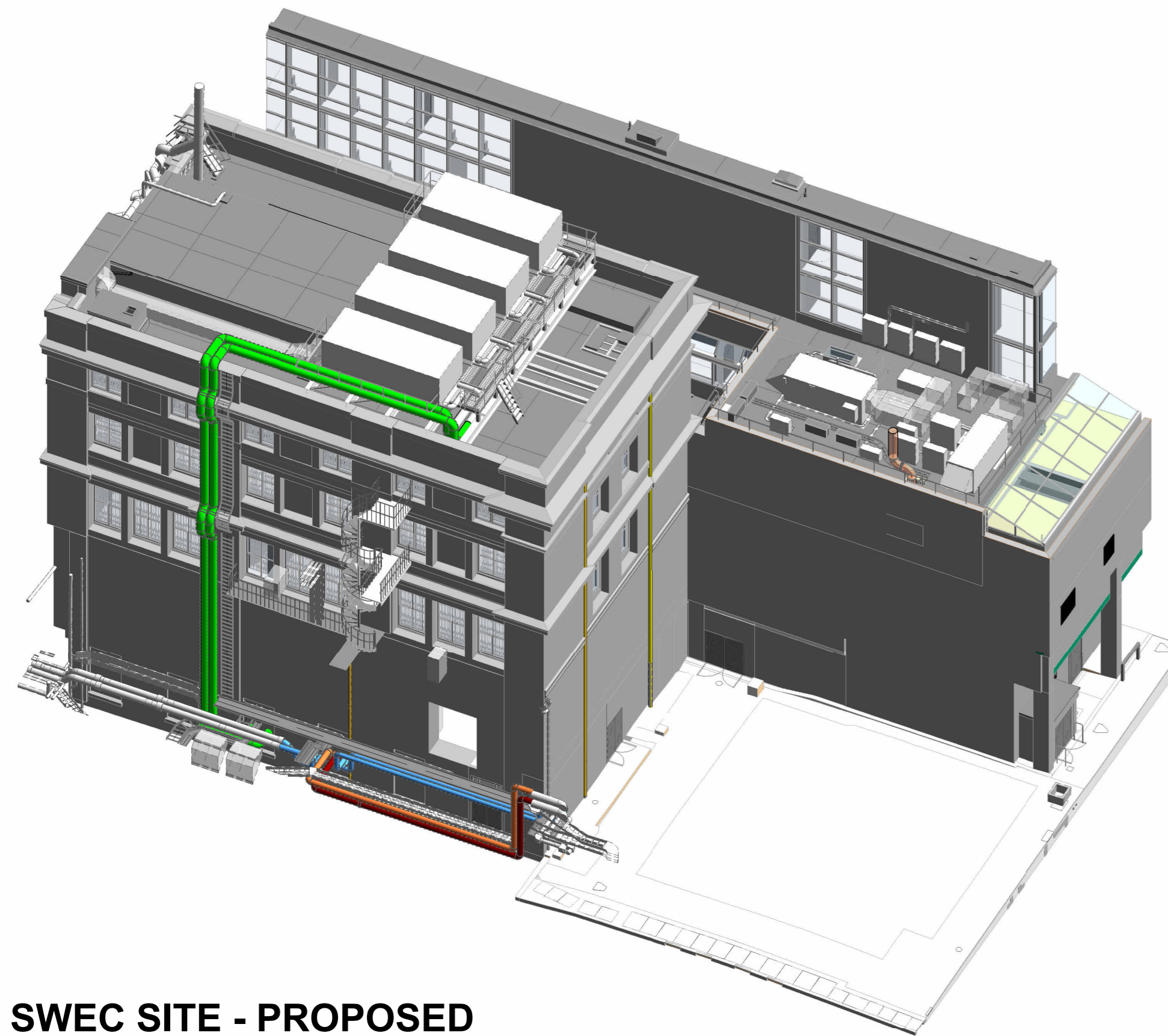
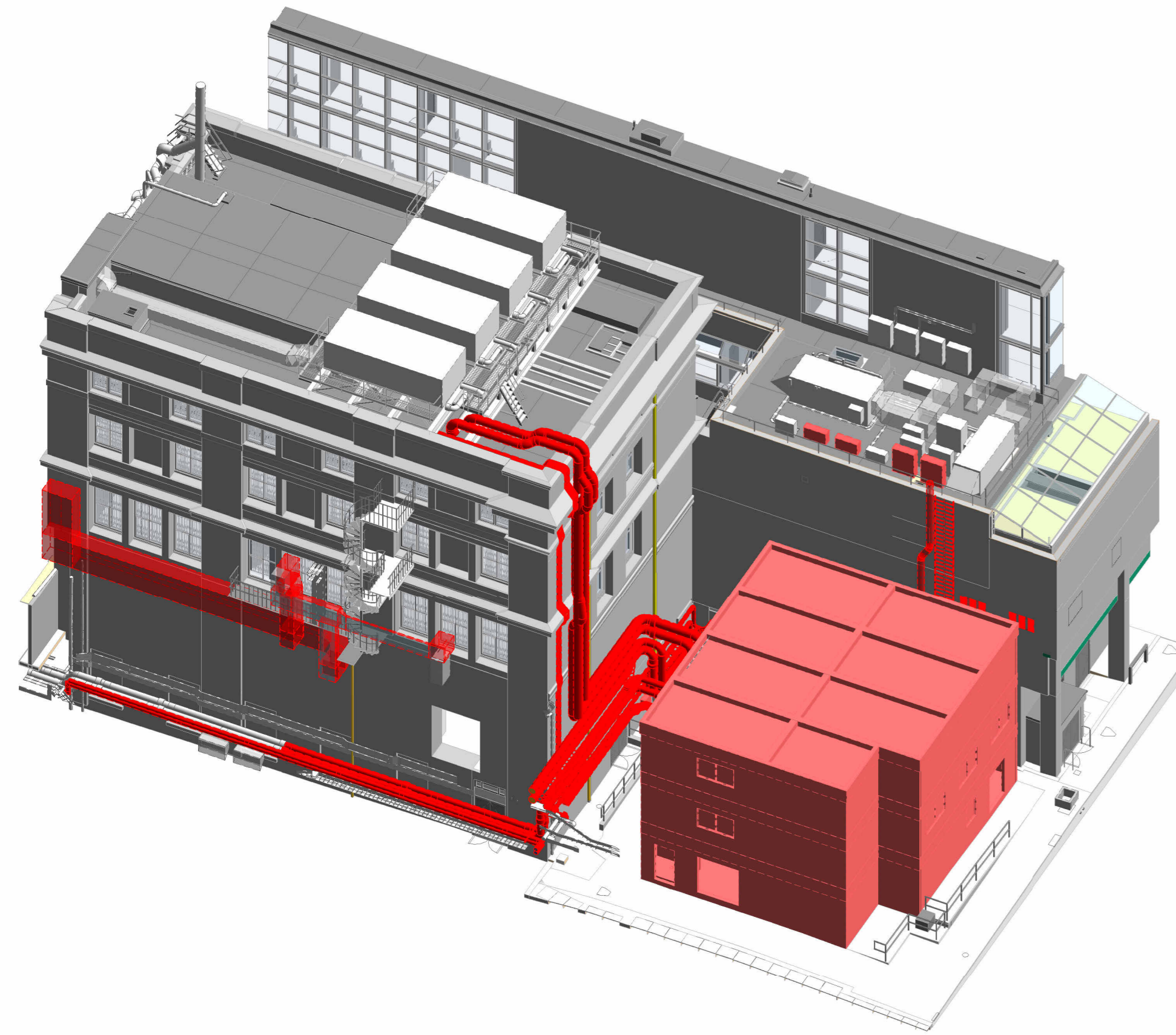
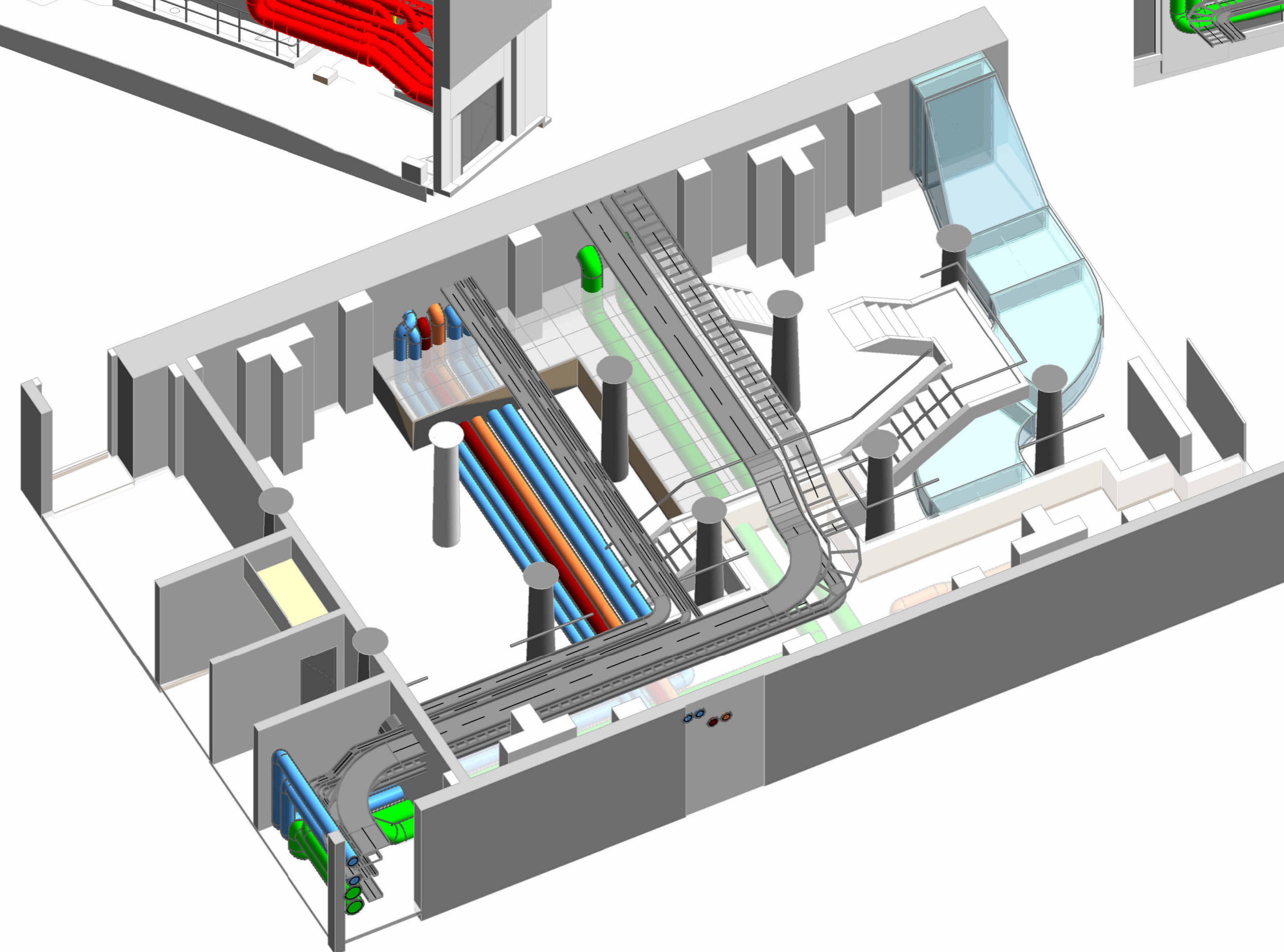
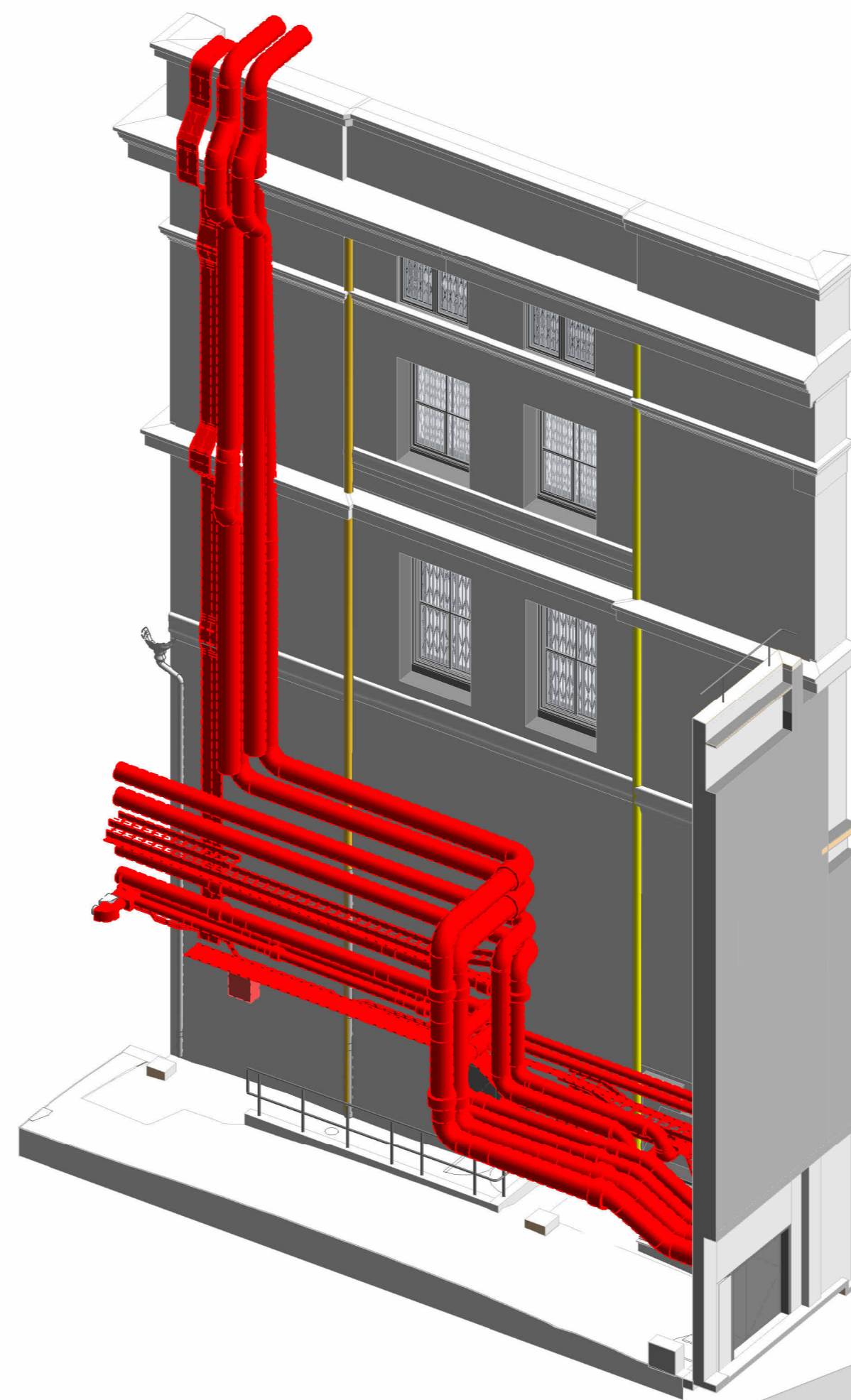


SWEC SITE - EXISTING & DEMOLISHED



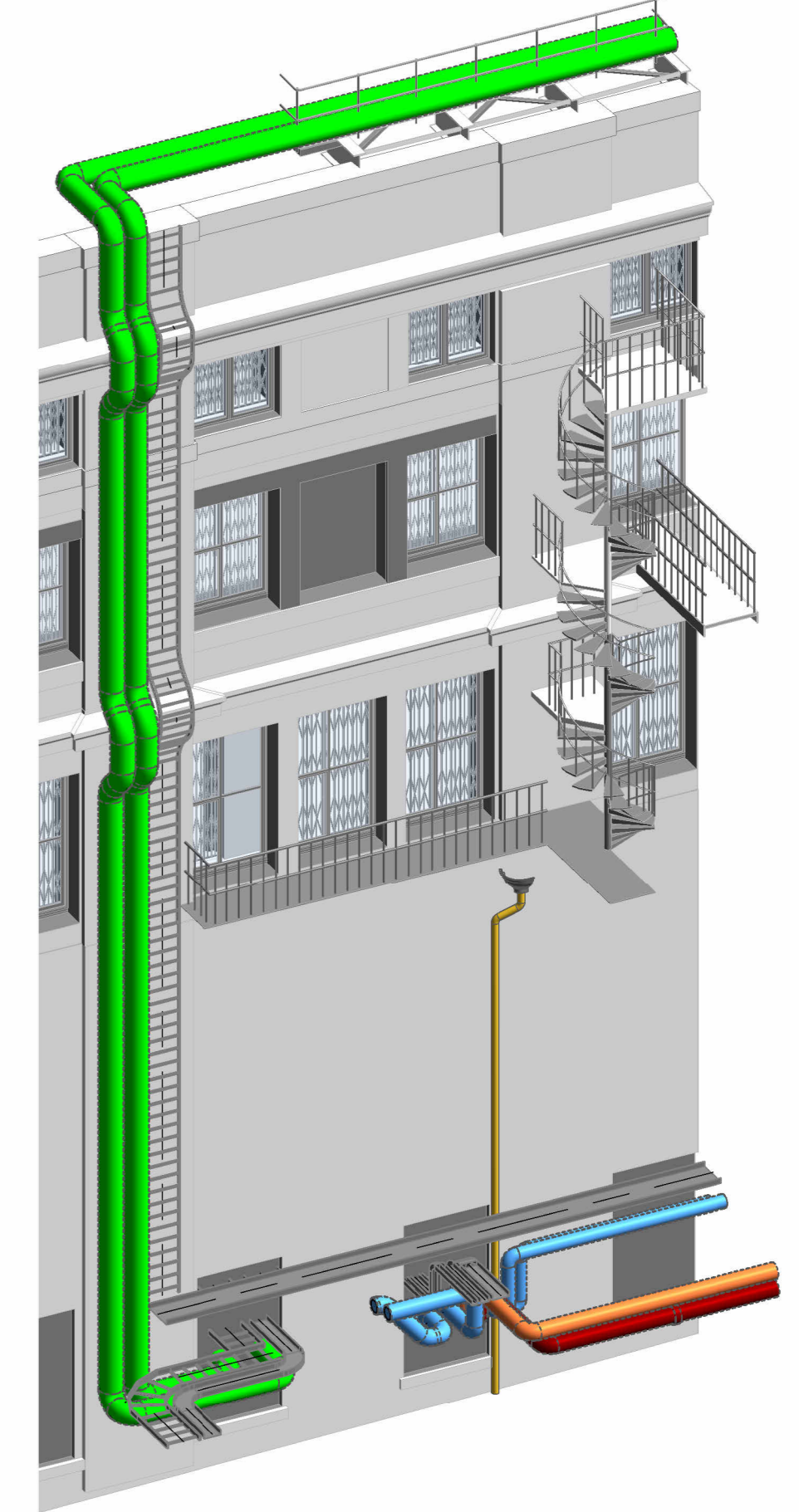
SWEC SITE - PROPOSED

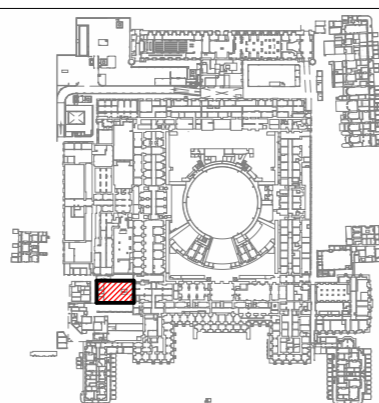
