First, the construction of the extension would place the historically important and irreplaceable Hilde Holger archive, which is housed next door at 27 Oval Road, at great risk. The archive, which is of great value to the history of dance, contains many fragile works on paper from the 1920's that could be damaged or destroyed by dirt and vibrations. Additionally, the loss of natural light that would result from the proposed extension would render it impossible for the archivist to do her work, which has been made so much more challenging by the loss of light from the Centric Close development (for which she had to be compensated). Finally, the Centric Close development behind 27 Oval Road has already caused major cracking, and tunneling, and digging in connection with the HS2 posses a further threat. Accordingly, the digging and piling that would result from the proposed two story extension of 29 Oval Road poses an intolerable additional risk to 27 Oval Road. This area was never intended to be overdeveloped in this way. While the extension may be desirable for the residents of 29 Oval Road their plan cannot be permitted to threaten the property and activities of the their neighbor(s). The council should exercise its authority under Article A4(D) to preserve the well being of the area by denying or removing the application. PS I should note that although I live in New York, I visit Oval Road three or four times a year. Through these visits I have been privileged to meet and get to know Primavera Bowman and to learn about the Hilde Holger archive.
