Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T218 (sycamore), T221 (Norway maple), T223 (sycamore), T486 (cherry), T488 (lime), T489 (cherry), T494 (holly), & T496 (holly) – In order to facilitate access to repair the existing retaining wall (comprising repointing and stitching works on its Site-facing aspect - see 2025/0063/P & 2025/0116/L), the crowns of these trees will be locally lifted only within the immediate vicinity of this retaining wall, in order to provide sufficient pedestrian clearance to complete these repair works from a 1.0m-wide scaffold platform - this will not exceed establishing a crown clearance above the retaining wall within the lower Site level of any more than 4.0m from the ground level at the base of the aforementioned tree stems (and at a minimum will comprise a crown lift from ground level of 2.0m). No first-order branches will be removed on T218, T221, T223, and T488. An arboriculturist will be present on the day when all crown lifting works are to occur, to monitor the progress of the tree works.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- Tree species
- The number used on the sketch plan; and

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
