Plane tree in front garden, re-pollard to most recent pollard points. The Plane tree is now getting too large and brushing against building and windows and neighbours are complaining about lack of light.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
