Large Plane tree on rear boundary of rear garden. Life crown to 3-4 metres, thin crown by 20% and reduce to most previous pruning points by removing 2-2.5 metres in height and 2.2.5 metres from side branches, leaving Plane tree at approximately 20 metres in height.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
