After extensive consultation with a tree surgeeon it has become apparent that both lime trees at 7 Rona Road, NW3 2HY need repollarding.

The lime tree in front garden will need Pollarding by 3.0Mtrs (Old Pruning Points)

The lime tree in Flat A (Private Garden) will need Pollarding by 3.0Mtrs (Old Pruning Points)

As recommended by tree surgeon.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
