London Plane (T1): Thin by up to 15%, selectively reduce over-longs to balance crown (max. 2-3m extension growth), remove epicormic stem & basal growth, lift canopy by 1-2m to uniform line. Appropriate maintenance pruning work in line with good arboricultural practice and to safeguard the health of existing tree(s) which represent an important amenity feature.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
