- Removing the existing step at the Highgate High Street entrance to provide step-free access.
- Lifting, carefully re-grading, and re-laying the existing Yorkstone pavers to create a shallow, compliant slope.
- Fabricating gate extensions to reduce the gap underneath the gates when closed.
- Cleaning, sanding and repainting of perimeter railings.
- Retaining and re-using all existing boundary materials to preserve the entrance's historic character and fabric.

The works aim to achieve a balance between modern accessibility requirements and the conservation of the site's heritage significance.
