A matching pair of historically appropriate fireplace surrounds in stone would be a suitable replacement for the non-original timber surrounds currently in place on the raised ground floor.

At lower ground floor a slightly less elaborated design appropriate to the subordinate nature of the room would be appropriate. No fire surround currently remains in this location.
