Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Growing adjacent to main garages:

T1: Mature Sycamore: Approximately 18.00m: Remove major dead wood throughout crown. remove partially severed and hung branches throughout crown.Remove low epicormic growth to crown break. Raise crown by approximately 2.00m over roof by means of removing the lowest limb growing northward which over hangs the garages. Control encroachment/General maintenance.

G2: 2 x Mature Hollies: Approximately 8.00m: (Upright tree) Reduce crown by approximately 2.00m-3.00m. Remove dead wood. (Leaning tree): Fell to ground level. Poor quality tree. General maintenance.

G3: Mixed species hedge/tree line Holly and Laurel: Approximately 6.00m-9.00m: Reduce height by up to approximately 3.00m-4.00m (dependant on individual tree heights and close to most recent reduction points). Reduce lateral and sub lateral growth, growing eastward towards the house by approximately 1.50m. Control encroachment/General maintenance.

T4: Weeping Ash: Approximately 7.00m: Reduce two main limbs by approximately 3.50m back to viable strong growth points. General maintenance.

T5: Mature Leyland Cypress: Approximately 13.00m: (Growing on soil/spoil mound): fast growing specimen growing in fairly close proximity to the building. Fell to ground level. To be replaced with a more suitable species. Landscaper happy to adhere to council suggestions and wishes to plant several trees to replace. Control encroachment.

T6: Thuja: Approximately 11.00m: Fell to ground level. Growing within close proximity of the building, to be replaced as part of the relandscaping project. Control encroachment.

G4L Group of Laurels: Approximately 6.00m: On northern boundary: Reduce by up to approximately 2.50m to re-shape. Reduce lateral and sub lateral growth over the garden by approximately 1.50m. General maintenance.

T7: Mature Sycamore: Approximately 20.00m: Overhanging the rear boundary, growing outside the curtilage of Weeping Ash: Remove major dead wood from section of crown overhanging weeping ash. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
