REAR GARDEN: 1 x Apple (T1) - Reduce by 1.5m - 2m and thin crown by 25%.  
1 x Sycamore (T2) - Crown reduction to previous points and remove 2 lower branches on trunk under main crown area.  
1 x Poplar (T3) - Fell to ground level.  
2 x Sycamores (T4) - Fell to ground level.  
1 x Sycamore (T5) - Crown reduction to previous points.  
1 x Sycamore (T6) - Crown reduction to previous points.  
1 x Ash (T7) - Fell to ground level.  
1 x Sycamore (T8) - Crown reduction to previous points.

The Council has considered your notification of intended works to trees dated 06 January 2025 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
