Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree reference is T33 in the submitted Arboricultural Assessment. It is a Sycamore tree, 12m in height, 0.54m diameter. It is a heavily reduced tree close to the boundary wall. Tight basal union decay in stem from ground level to 1.5m. The tree has been graded as U (or at best a low C grade tree) and highlighted for removal. However, the tree is an off site tree (Eton Place) and its removal is not a prerequisite of the proposal.

As mentioned the tree is situated at Eton Place which is a neighbouring property to our construction site at 5-17 Haverstock Hill, NW3 2BP. The branches of the tree extend onto our land which will prevent the piling works from being carried out. In order for the piling works to be carried out, crown reduction is required to ensure that the branches do not extend beyond the site boundary. The amount of reduction proposed is 2m, this is the distance that the branches protrude onto the site.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
