We write on behalf of MBNL (EE (UK) Ltd and H3G (UK) Ltd), to make a formal full planning & listed building application for the proposed installation of telecommunications apparatus at the above location. The upgrade is necessary due to major re-roofing works which are taking place at the property and the upgrade will meet EE and H3G's specific technical and operational requirements. The proposed scheme follows pre-application discussions with your department, and we now make a formal application to you as planning authority.

EE and H3G 'Three' had an existing telecommunications site upon the rooftop of the London School of Hygiene and Tropical Medicine, a four-storey educational establishment. Major works are being carried out to the rooftop of the building and the majority of telecommunications equipment has been removed from the building. To maintain coverage and capacity during the intervening period, EE and Three have temporarily positioned some apparatus upon some purpose-built scaffolding towards the front of the property. Once the roof works are complete, EE and Three will then relocate back onto the building. The proposed scheme will include the installation of 6no. radio antennas, 4no. transmission dishes and ancillary apparatus which will be fixed to three separate tripod support frames, along with the installation of 3no. equipment cabinets which will be fixed to a metal support grillage. Further details are included within the enclosed documentation.

The sum of £648 made payable to the London Borough of Camden Council in respect of the planning application fee (paid via the Planning Portal). We trust this will be acceptable and look forward to discussing the merits of this proposal with you in the near future.
