The Council has considered your application and decided to **refuse** planning permission for the following reason(s):

Reason(s) for Refusal

1 The air source heat pump units and louvre screening, by reason of their size, design and location, result in a dominant, incongruous and disproportionate addition to the roof top, causing harm to the character and appearance of the host building and conservation area and to the setting of the adjacent Grade II* Listed Building, contrary to Policy D1 (Design) and D2 (Heritage) of the Camden Local Plan 2017.
