## AS per Indigo Survey provided

#### **CENTRAL GARDEN**

- T1-Sweet Chestnut(Castanea sativa)
- -remove reaction growth from main stem to above gutter height
- -prune branches to provide 1m clearance for railings and building incl.removing 1x branch that will be in the way of the proposed renovation work
- -remove all deadwood

#### **REAR GARDEN**

T2-Olive(Oleo europaea)

- -fell to ground level
- -grind out stump to 300mm below ground level(re-planting)

#### **REAR GARDEN**

T3-Apple(Malus)

- -crown reduce no further than previous points of reduction
- -thin crown by 15% to reduce density and allow more air/light through canopy
- -removal of any dead or crossing branches

#### **REAR GARDEN**

T4-Acacia-dead

- -section fell to ground level
- -grind out stump(45cm diameter) to 350mm below ground level(re-planting)

#### **REAR GARDEN**

T5-Cherry(Prunus)-in poor form due to past pruning,

- -fell to ground level
- -grind out stump(15cm diameter) to 350mm below ground level

#### **REAR GARDEN**

T6-Judas Tree(Cercis)

-light pruning of south-facing elongated limb to reduce weight by 50-60cm

## FRONT GARDEN

T7-Weeping Willow(Salix sepulcris)

- -reduce lateral branches to allow clearance by 1m+ from front elevation
- -crown lift lowest branch re-growth by up to 3m
- -thin to remove 60% of reaction re-growth from pollard points retaining most dominant regrowth>then reduce regrowth by 1.3m to encourage form and structure suitable for repeat pruning
- -remove large section branch to elbow(4m length on the western side (see attached photo) to reduce weight and mitigate risk of falling branch on neighbours side
- \*\*\*NOTE\*\*\*

We observed multiple Squirrel 'holes' that may compromise the trees integrity, removing some weight is prudent.

### FRONT GARDEN

T8-Evergreen Magnolia(M.grandiflora)

-reduce lateral branch lengths from neighbours' buildings provide 1m clearance

Works to T1, T3, T6, T7 & T8 are for routine maintenance.

Works to T4 are due to trees being dead and to T5 due to the tree being in poor form due to past pruning works.

T2 works are due to being planted in incorrect position and has been poorly pruned - now misshapen. Plans to relandscape and replant.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
