T2: Maple - Crown lift canopy to 3.5m and remove dead wood Maintenance works in line with good arboricultural practice
G1: 10 x Limes - Crown reduce the height and spread to previous reduction points (approx. 1.5m height and 1m spread) Maintenance works in line with good arboricultural practice
G3: 2 x Lime - Crown reduce the height and spread to previous reduction points (approx. 1m height and 1m spread) Maintenance works in line with good arboricultural practice
T4: Oak - Crown lift canopy to a height of 5.0m Maintenance works in line with good arboricultural practice
T5: Mimosa - Crown lift canopy 0.8 – 1.0m above the adjacent black metal railing Maintenance works in line with good arboricultural practice
T6: Sycamore - Reduce extremities growing towards building to give a clearance of 1.5m Maintenance works in line with good arboricultural practice
T7: Loquat - Reduce extremities growing towards building to give a clearance of 1.5m Remove two secondary stems growing to the West Reduce unruly spread to shape and balance (approx. 1m) Maintenance works in line with good arboricultural practice
G8: 5 x Acacia - Reduce unruly height and spread (approx. 0.5m height and 0.3m spread) Crown lift to a height of 2.0m Crown thin by 15% and remove dead wood Maintenance works in line with good arboricultural practice
T9: Large Hazel - Cut to ground level This tree is growing too close to the building

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
