## 34 BELSIZE LANE, LONDON, NW3 5AE APPLICATION FOR APPROVAL OF DETAILS RESERVED BY CONDITION PURSUANT TO APPLICATION REF: 2024/1219/P

On behalf of the Applicant, '34 Belsize Lane Ltd', we hereby enclose documentation to discharge Conditions 6 (Green / Sedum Roofs) and 10 (PV Panels) of Planning Permission dated 6 August 2024 (ref: 2024/1219/P). The conditions are worded as follows:

## Condition 6 – Green / Sedum Roofs

Prior to the relevant works commencing, full details in respect of the green/sedum roofs shall be submitted to and approved by the local planning authority. The details shall include:

- 1. A detailed scheme of maintenance
- 2. A plan and section at a scale of 1:20 with manufacturers details demonstrating the construction and materials used
- 3. Full details of planting species and density

The green and sedum roofs shall be fully provided in accordance with the approved details prior to first occupation and thereafter retained and maintained in accordance with the approved scheme.

## • Condition 10 – PV Panels

Prior to installation of the PV panels hereby approved, detailed plan showing the location, number and angle of photovoltaic cells to be installed on the building shall have been submitted to and approved by the Local Planning Authority in writing as well as a maintenance plan. The measures shall include the installation of a meter to monitor the energy output from the approved renewable energy systems. The cells shall be installed in full accordance with the details approved by the Local Planning Authority and permanently retained and maintained thereafter.
